- That the undersigned does reserve the right to discontinue renting at any time, and that the monthly rental charges will stop when the rental instrument has been received by S.S.E. Music;
- That it is the undersigned's responsibility to return the above instrument to S.S.E. Music at the time when they wish to discontinue renting;
- That the full title and ownership of the above instrument shall remain with S.S.E. Music Inc.;
- That the undersigned shall pay all costs of replacement or repair in the event that the above instrument is stolen, damaged, or destroyed, above and beyond anything covered by any repair credit or the renter's private insurance;
- That the undersigned shall pay any fees necessary for any legal restitution of the above merchandise or for the collection of monies past due;
- S.S.E. Music, Inc. has the option at any time to terminate this contract if the undersigned is in default hereunder as defined in No. 425.103(2) of Wisconsin Statutes. In such event the rental customer agrees to promptly return or where necessary make rented property immediately available for pickup;
- That the undersigned has the option to purchase the above rental instrument for the retail price of the instrument **less all rent paid for a total of twelve months or thirty per cent of the retail value, whichever of these credits is greater. However, these credits cannot exceed fifty per cent of the retail price. This option may be exercised only if this rental contract is not in default.**
